## DEFINITIONS

### 1. Ex-servicemen (ESM)

- 1.1 An ESM is a person who has served in any rank in the Indian Armed Forces, including the Army, Navy, and Air Force.
- 1.2 They are individuals who have been retired, relieved, or discharged from service.
- 1.3 The term "Ex-Servicemen" is used to recognize and provide benefits and opportunities to those who have served in the armed forces.

### 2. Dependents

- 2.1. **Spouse.** The ESM's current spouse is usually considered a dependent.
- 2.2. **Children.** Legitimate, step, and legally adopted children of the ESM are considered dependents, especially if they are unmarried and below a certain age (often 25).
- 2.3. **Dependent Parents.** Parents of the ESM may be considered dependents if they reside with the ESM and their combined income from all sources does not exceed a certain limit (currently Rs. 9000/- per month, excluding dearness allowance, according to ECHS guidelines).
- 2.4. **War Widows/Dependent Parents of Deceased Personnel.** In some cases, the widows and dependent parents of defense personnel who died in war or while on duty are also considered dependents and eligible for benefits.

### 3. Veer Nari.

The widow of an armed forces member who has laid down his life for the nation, whether in war or in a military operation is termed a "Veer Nari".

### 4. Widow.

A woman whose husband has died and who has not married again.

### 5. Physical casualty.

A "Physical Casualty" refers to a person who has been injured or killed due to an accident, war, or other destructive event. It's a general term encompassing both fatalities and non-fatal injuries, with the word "Casualty" often used to describe multiple deaths and injuries.

### 6. Battle Casualty.

A "Battle Casualty" in the context of defence personnel refers to any casualty (death, injury, or disappearance) sustained as a direct result of hostile action or combat. This includes situations where personnel are killed or wounded in combat, or die from wounds or injuries sustained during such action. The term also encompasses missing personnel presumed to have been lost due to enemy action.

- 6.1. **Categories.** Battle casualties can include those killed in action, those who die from wounds or injuries sustained in battle (other than self-inflicted), those who are wounded or injured in battle (other than self-inflicted), and those who are missing and presumed to have been lost due to enemy action.

- 6.2. **Distinction from Non-Battle Casualties.** It's crucial to distinguish between battle casualties and non-battle casualties. Non-battle casualties include those who die or are injured due to illness, accident, or non-combat-related injuries.

## **DEFINITIONS**

### **Veterans**

7. A defence veteran, generally referred to as a military veteran, is a person who has served in the armed forces (including the military, navy, air force, or space service) and has been discharged or released under conditions other than dishonorable.

7.1. The five types of veterans are as under:-

- 7.1.1. Wartime Veterans
- 7.1.2. Peacetime Veterans
- 7.1.3. Combat or war Veterans
- 7.1.4. Service Veterans
- 7.1.5. Disabled Veterans.

## TYPE OF PENSION

1. **Ordinary Family Pension (OFP).** Ordinary Family Pension is normally paid to the widow for all cases of death after retirement and for those cases of death while in service where the death is neither attributable to nor aggravated by service (NANA). It is paid @30% of last reckonable emoluments (Band Pay, Grade Pay, MSP & NPA for medical officers) + dearness relief (DR). OFP will stop on remarriage except for widows who are issues less. For widows with children, it will pass on to her eligible children as per their seniority.

1.1. **Enhanced Ordinary Family Pension (EOFP).** This pension is basically an ordinary family pension which has been enhanced for a limited period as a benevolent measure by the Govt for cases of death while in service and for an early death after retirement.

1.2. Enhanced ordinary family pension is paid @ 50% of last reckonable emoluments + DR. It is paid for 10 years to the widow for death in service. There is no upper age limit. For death after retirement, it is paid for 7 years after death or up to 67 years of age of deceased officer (65 years for pre-13 May 1998 retirees). For a widow to be eligible for enhanced ordinary family pension (EOFP), a minimum of seven years qualifying service is required to have been rendered by the deceased officer.

2. **Special Family Pension (SFP).** Nominally SFP is given to the widow for death of an officer while in service where the death is attributable to/or aggravated by service. It is paid @ 60% of last reckonable emoluments + DR. However if an invalidated out officer dies within seven years of his invalidation out of service and in the medical opinion his death has been primarily caused by the disability for which he was invalidated out of service, then the widow could be eligible for SFP. SFP will not stop after remarriage. However if widow does not support her children it can be divided between the widow and the children.

3. **Liberalized Family Pension (LFP).** LFP is granted for death which besides being attributable to and aggravated by service should take place in the face of enemy (in war/on border/notified operations), engagement with militants, while trying to maintain law and order amongst unruly crowds, weather extremities during op deployment, fratricide in combat heat, Battle inoculation training exercise, death in Op deployment due to snakebite, poisoning of water by enemy etc. The recommendation for LFP will depend on the circumstances of death as emerging out of Court of inquiry/injury report and subsequent medical opinion on death. It is paid @ 100% of last reckonable emoluments + DR. LFP not stop after remarriage. However if widow does not support her children after remarriage, it will be divided between the widow and the children.

## VETERANS FACILITATION CENTRE (VFC), BAREILLY

### **General**

1. Bareilly Cantt, an important military station caters to the needs of approx 9,44,337 ESM, Widows, Veer Naris and their dependents who are located in and around Bareilly and this population continues every year. These Veterans face routine difficulties as regards their post retirement entitlement, employment and Medicare.
2. To address these issues of the Veterans due to non availability of an institutionalized redress mechanism, a 'Veterans Facilitation Centre' (VFC) has been established adjacent to ECHS Polyclinic Bareilly. The VFC under the aegis of Veterans Branch, HQ UB Area, Bareilly is functional wef 02 Aug 2018.

### **CHARTER OF DUTIES VFC**

3. The VFC has been est with the aim of providing all types of assistance to Veterans/Veer Naris, Widow, war disabled soldiers and their dependents in the AoR of Stn HQ Cell Bareilly and incl the district of Badaun, Rampur, Moradabad, Pilibhit, Sambhal and JP Nagar(Amroha).
4. **Facilities/Assistance.** The VFC is equipped with 05x comprtr on Internet with one comprtr operator each. The assistance provided incl: -
  - 4.1. On line Regn of ECHS Card.
  - 4.2. On line Regn of DIAV Portal.
  - 4.3. On line Regn on RODRA.
  - 4.4. Jeevan Praman Patra (Mantra)
  - 4.5. ADLRS/Demise Grant.
  - 4.6. Pension anomaly.
  - 4.7. Penury grant cases for non pensioners.
  - 4.8. Edn scholarship of ward of NOKs of ESM.
  - 4.9. Claim for daughter marriage cases upto rk of Hav.
  - 4.10. DLC/MLC on SPARSH Portal.

3.1. **Reservation Quota in PSBs & CPSUs.** The existing quota of reservations available for Veterans in Public Sector Banks (PSBs) and Central Public Sector Undertaking (CPSUs) in which widows can apply are as follows:-

3.1.1. 14.5% in Direct Recruitment Group 'C' Posts.

3.1.2. 24.5% in all Direct Recruitment Group 'D' Posts.

**Note:** This includes 4.5% for Disabled Veterans and Dependents of Service personnel killed in action (Applicable to widows also).

3.2. Central Civil Services & Posts (CCS&P) of Central Government Ministries/Departments quota for Veterans is as follows:-

3.2.1. 10% in all Direct Recruitment Group 'C' Posts.

3.2.2. 20% in all Direct Recruitment Group 'D' Posts.

**Note:** The benefit of reservation has been extended to two dependents (including widows) and given Priority II-A to secure a job in Group 'C' & 'D' categories of posts under Central Govt Org.

6.1. **Distress Grant.**

6.1.1. Financial Assistance incl Medical Distress Grant is being provided from AG's Welfare Fund to give financial relief to all rks including ESM and their widows/NOK/dependents, when they are under distressed circumstances for the purpose of their maintance and subsistence. Cases of offrs are dealt by Accts Section of CW Dte & cases of JCOs/OR (Physical Casualties) are dealt by CW-4. All cases of Battle Casualties are being dealt by DIAV. Financial assistance is provided on case to case basis depending on the merit of each case.

6.1.2. Form DD-40 for , Veteran, widows & dependents duly authenticated by ZSWO/RSB or a serving Lt Col are to be fwd to CW-4 along with sp docus (Veterans Branch, HQ UB Area may be approached for assistance).

6.1.3. Application scrutinized & grant approved on a case to case basis on merit of case.

## ACTION TO BE TAKEN BY THE SPOUSE / NOK DEMISE OF A PENSIONER

1. **Step 1.** Death, if due to any accident or unnatural causes, should always be **reported to the nearest police station**. It resolves a lot of legal and documentation issue at a later stage. In such cases, it is also advisable to **get the auto pay done** to establish proper cause of death.
2. **Step 2.** Do obtain **two ink signed copies of the medical certificate** specifying the cause of death from the hospital or an authorized medical practitioner. One copy is required by the authorities at the cremation / burial ground. And the second copy is required by the Registrar of Deaths & Births to issue death certificate. Do **obtain the cremation burial certificate from the cremation / burial ground**.
3. **Step 3.** A close relative should **apply for issue of death certificate within 15 days of the death** of the pensioner / deceased. The family must obtain around 20-30 ink signed & **equal number of photo copies** duly attested by a class **one officer** for necessary documentation.
4. **Step 4.** Write to the Pension Disbursing Authority (PDA) i.e. the pension paying bank intimating them of the demise of the pensioner and commence payment of the family pension of the spouse / NoK/ Heir, enclose an ink signed death certificate and copy of the original PPO with joint photograph of the pensioner and spouse / NoK duly starting the PPO and Pension Account Numbers. A sample application form is attached as an Annexure I.
5. **Step 5.** If the Pension Account is a join account or the spouse is a nominee, then it is easy to operate the same account for family pension, otherwise a fresh bank account is required to be opened in the same bank. The authorities will require a **proof of identity and residence**. Photo copy of Voter Identity Card / PAN Card should suffice with three copies of attested photographs.
6. **Step 6.** **Apply to MP5 B to process the case of family pension and also write separately to Pension Sanctioning Authority i.e. PCDA (P) to commence the family pension stating the demise of the pensioner** duly enclosing an ink signed copy of death certificate. A sample application is attached as Annexure II.
7. **Step 7.** Do write to Army Group Insurance Fund (AGIF) to draw payment on extended life insurance if eligible. A sample application is attached as Annexure IV.
8. **Step 8.** Return the deceased pensioner identity card to the nearest Station HQ ZSB for further disposal. And apply for new identity card to ZSB.
9. **Step 9.** If there are other insurance policies on the name of the deceased soldier then do write to the insurance companies to pay the due amount.
10. **Step 10.** Write to all bank wherein the pensioner has his accounts to transfer the closing balances to the spouse / NOK Providing them with the bankers address and account number.
11. **Step11.** Write to the Regional Transport Office (RTO) to transfer the car / two wheeler / any other automobile to the NOK.
12. **Step 12.** Write to concerned Arms Licensing Authority to transfer the weapon (if held) to the NOK and meanwhile deposit the weapon (s) at the concerned Police Station for safe custody. Later, the NOK should apply for Arms License at the earliest.

13. **Step 13.** Write to the Electricity Providing Agency to transfer the meter in the name of spouse / NOK and start further billing against that name.

14. **Step 14.** Write to the telephone providing agency to change the name of the subscriber, transfer the connection to the name of the spouse / NOK for further billing.

15. **Step 15.** Apply to AWHO transfer the dwelling unit to the spouse / NOK. Performa for application should be obtained from the AWHO/ Resident Welfare Society. The Resident Welfare Society has to render No Objection Certificate (NOC) stating that there is no encroachment of common land, no major modification to the approved design and all dues to the society have been clear. If not already done, you may have to do it before they issued NOC.

16. **Step 16.** Write to all the club and societies to transfer the membership to the spouse / NOK. Write to all debtors to clear all dues and make payment to the spouse/ NOK.

17. **Step 17.** Clear the outstanding dues and credit card held / taken if any. Return the cards of the deceased pensioner to the bank concerned.

18. **Step 18.** Some of the banks may have issued insurance certificate for the amount of the FD / bank balance then the same should be claimed.

19. **Step 19.** Write to income tax authorities to intimate death of the pensioner to close his Income Tax file and consequently open an Income Tax file in the name of the spouse / NOK quoting the PAN number of both the deceased pensioner and the spouse.

20. **Step 20.** Write to Municipal authorities to Close Property case file of the deceased person and open it in the name of the spouse/ NOK.

21. **Step 21.** Approach the District Courts for Probate of the WILL, if it is in possession; otherwise obtain a Succession Certificate from the District Judge. Relevant instruction are summarized as a check list at Annexure V.

1.2 **Eligibility Criteria for ECHS Dependents.** Dependents (children and parents) are eligible for ECHS benefits only if their monthly income is below Rs. 9,000+DA (currently Rs. 13950, based on 55% DA). Dependents exceeding this income should no longer be eligible for ECHS benefits, and their cards will be blocked.



#### **DRAWL OF STORES BY ATTENDANTS OF ELDERLY AILING MEMBERS**

1. It has been decided to permit the attendants of the elderly ailing members to draw the stores and liquor on their behalf on the basis of a suitable certificate from the medical specialist in that field and counter signed by the competent authority under whose jurisdiction the canteens are operative. Needless to say that while this concession is being extended as an effort to provide succor to the ailing members of the defence services fraternity the authorities/management at all levels should ensure that this concession is for the genuinely needy. Methodology/measures to be adopted including the nature of authority letter alongwith suitable checks may be decided at respective Command HQ level please.
2. This has the approval of the QMG.
3. Format for med cert to be rendered by med auth and that for authorisation of dependent for collection of grocery stores/liquor is att as per Appx A & B.
4. It will be mandatory for auth pers to carry the following docus while vis the canteen:-
  - 4.1. Canteen Smart Card.
  - 4.2. Med Cert of Smart Card holder.
  - 4.3. Auth letter issued by Col Veterans.

We may suitably title it as - **“AFTER ME”** Folder or any other appropriate name.

### **Suggested Documents that may be kept in this Folder.**

- (a) PPO- Original and subsequent corr PPOs, incl the one having correct name and date of birth of spouse. SPARSH PPO No, Login id & password must also be clearly mentioned.
- (b) Service Particulars Booklet/ Discharge Book issued by ORO/ Records Office on retirement.
- (c) Extended Insurance (EI) Scheme Certificate issued by AGIF.
- (d) Details of all Bank Accounts, Credit Cards, Loans and Lockers.
- (e) Photocopies of all cards: ESM Iden, ECHS, CSD, Aadhar, PAN, DL etc.
- (f) Passport, Arms License, Veh Regn as applicable.
- (g) Details of investments: MF, FD, RD, NSS, MIS etc.
- (h) Details of Immovable Property along with documents.
- (j) Details of Club Membership.
- (k) Income Tax Details including IT Portal login id & password.
- (l) Copy of WILL.
- (m) Format of letters for claiming of Pension, AGIF, Demise Grant/ ADLRS.
- (n) Contact details of DIAV, Col Veterans of your local area: ZSB, ECHS, ESM Helpline, Station HQ, CMP Desk.
- (o) Login Id and Passwords of SPARSH, RODRA, ECHS, Internet Banking, Mobile, Email etc

## SAINIK BANDHU MEETING MECHANISM

### General

1. Armed Forces are the custodian of sovereignty and integrity of the country. All defence personnels get dply all over the country during their service to safe guard their motherland. During their service, the families are more often than not, separated and continue to stay at their village. These families have to face numerous challenges while handing their day to day life. The soldiers, when they learn bout thesechalanges, are under tremendous stress which affects their functioning and performance in their official tasks. They often resort of resolving these issues by personally addressing them to the concerned civ adm however the follow up and resolution is very difficult. At times, these indl apch their Commanding Offr who in turn apch the civ adm for resolution/redressal of the grievance. There is however no structured mythology for progressing such complaints till their logical conclusion.
2. The State of Uttar Pradesh (UP) has a system in place in term of "**Jansunvayi**"/**Integrated Grievances Redressal Sys (IGRS)** web portal for all residents of UP who can register any grievance on which a time based action is taken and a feedback is given to the complaint. There is however no separate portal for serving soldiers. This facility is not utilised much by serving soldiers and their families due to lack of awareness and/or lack of expertise to register on an online platform. Some veterans and their families are utilising this facility for redressal of their grievances.
3. Also, in the State of UP there is a forum called '**Sainik Bandhu**' in which officers of Distt adm and deputed reps from the nearest Stn HQ sit together to resolve all grievances of soldiers and their families. Due to the vintage of these dirns & lack of awareness about such a forum, the grievances do not reach this body.
4. HQ Central Comd, alongwith the civ Administration of State of UP has got together to address the sys of redressal of grievances of the Soldiers and their families who reside in the state of UP. The System will be for all three Services as well as for veterans, however this SOP is ltd the procedure to be followed by Serving Soldiers of Indian Army.

### Aim

5. The aim of the SOP is to laydown the procedure to be followed by all Serving personnel who are residents of UP for redressal of their pers grievances.

## ORGANISATION FOR REDRESSAL OF GRIEVANCES.

6. **Jansunvayi/Indl Grievances Redressal Sys (IGRS).** The State Govt is in the process of modifying the IGRS Portal with a dedicated tab for service pers. This tab will have the fwg facilities:-

6.1. The tab will open a Graphical user interface which will have fwg option:-

6.1.1. Serving/Veteran will detls to be fed on indls detls incl unit address etc.

6.1.2 Type of Complaint (drop down Menu)

6.1.2.1. Police

6.1.2.2. Revenue

6.1.2.3. Civ

6.1.2.4. Misc

6.2. Option of uploading the scanned copy of the complaint.

6.3. Distt/Tehsil of complaint.

6.3.1. Access right to this tab will be given to all Stn Cdrs, Sub Area GOCs of PUP&MP SA, PUPSA and to HQ Central Comd, A br only.

6.3.2 Access will also be given to concerned Civ administration incl DMs, DIG, Land & Revenue offrs and to the nominated offr at the Chief Secy, UP office.

6.3.3 Complaints once recd, will be uploaded, monitored and processed on this app at all levels who have access rights to the tab.

7. **District Level Org.** The existing sys of Sainik Bandhu will be rejuvenated. The sch of the Monthly Sainik Bandhu mtg will be shared by all DMs to the Stn Cdr. Stn Cde or his nominated rep (not below a Fd offr) will attend all Sainik Bandhu Mtgs with ther DM or his nominated rep preferably in person or on VC.

## PROCESS FOR REDRESSAL OF GRIEVANCES

9. **Action by Complaint & Commanding Offr.** All serving pers, who are facing any grievance will write a pers to his CO/OC. The CO, will ascertain the issue and if deemed appropriate, will send this appln under a covering letter addsd to Stn Cdr under whose area the district of the soldier resides. A copy of the same will also be endorsed to the concerned Sub Area. List of all Sub Area, Stn HQ and their districts of State of UP is at Appx A. The CO/OC will mention the type of complaint i.e.Police/Revenue/Civ/Misc for case of segregation and better follow up.

## 10. Action by Stn Cdr.

10.1. On receipt of the complaint, Stn Cdr will segregate the complaint as per the category it belong to and feed it in the “**Jansunvayi** IGRS Portal”. This complaint will be accessible to the DM of the concerned Distt who in turn will mark it to the concerned civ offr for action.

10.2. Complaints recd during the month will be discussed in Sainik Bandhu Mtg & prog/resolution from Civ aedm will be obtained. A progres will be uploaded by respective Stn Cdr within 72 hrs of the Sainik Bandhu Mtg. Similarly the DM of the concerned district will also upload his update on the IGRS Portal.

## 11. Action of HQ Comd/State of UP.

The committee as mentioned at Para 8 will meet regularly as per fwg details:-

- 11.1. At least 50% of the members of the committee will be the quorum for the meetings.
- 11.2. Presence of at least two officers of the defence services as a member shall be mandatory to satisfy the quorum.
- 11.3. All undersolved cases or those recommended by Stn Cdr will be discussed for early resolution.

12. **Reply to Petitioner/Complaint.** Endeavour must be made to ensure that all grievances as addressed within one month. The fwg procedure will be adopted:-

12.1. A written reply to the CO of the petitioner will be fwd by Stn Cdr within 7 days of the completion of the Sainik Bndhu mtg.

12.2. In case, the case is still under prog, these monthly replies will be fwd by the Stn Cdr after every Sainik Bandhu mtg till the final resolution of grievances.

12.3. In case the Commanding Offr is not satisfied by the resolution given by the State Govt, he may refer the case directly to A Br, HQ Central Comd for raising the issue at the Appx level.

13. **Process for Veterans.** All complaint by veterans recd from various channels will be fwd to respective Stn HQ. These appln will be uploaded in the 'Veterans' tab of the IGRS portal by SO Veterans/nominated offr and will be processed for redressal in a similar manner as that of serving soldiers.

14. **Access to IGRS.** The sys is being mod to grant access to concerned apt with user name & password. The detls will be shared separately. Till the portal stabilises the complaints will be processed manually in similar manner as explained above.

## **Conclusion**

15. Resolving the grievances of Soldiers and Veterans in least possible time frame by all the stake holder so as to keep our men stress free. This can only be effective with diligence and consistent pursuance by all stake holders.

2. **Ex Gratia amount given by Uttar Pradesh Government.** Natives of Uttar Pradesh whose family is residing in Uttar Pradesh and who die outside the state as a result of violence caused by terrorist/anarchist elements, internal issues on the country's border or sporadic border incidents of fighters/terrorists or extremist etc while performing their duties in the Indian Army and die within Uttar Pradesh under the same circumstances while performing their duties, their dependents are given approval of an amount of Rs. 50 Lakhs by the Government Order No 307K/Ch- Sanipar-20-15(25)/2018 dated 29 Jul 2020.

**3. Employment of dependents of martyred soldiers of Uttar Pradesh.** Under the Government Order 19 Mar 2018 issued by the said Government, provision has been made for providing compassionate appointment to the dependent of the martyrs (Battle Casualty) of the Army, Navy and Air Force who are native of Uttar Pradesh, which is effective from 01 Apr 2017.

**4. Exemption in stamp and registry fees for legal dependents of ex-servicemen/martyred soldiers.** As per the order of Stamp and Registry Section, Uttar Pradesh Government letter no 25/2016/888/94-Sta-Ni-2-2016-500(64)/80 dt 11 Nov 2016, ex-servicemen and legal dependents of martyred soldiers will be given exemption on stamp duty on the first valuation of Rs. 20 Lakhs for property purchase.

**5. Regarding exemption from house tax to the wives of martyred soldiers.** Exemption from house tax has been provided to residential buildings owned by widows of soldiers who have been martyred in the defence of the country. This exemption is being given only under municipal corporations and is not applicable for ex-servicemen.

**6. Reservation of allotment of plots/constructed buildings to ex-servicemen.** Under the authority government order No 2905/37-2-91-94 MB/91 dt 25 Nov 1991, the Uttar Pradesh government has approved 3% reservation in the allotment of houses and house plots built by the UP housing and development Council and the state development authority to serving personnel, ex-servicemen and dependents of soldiers killed in war.

**7. Reservation for ex-servicemen in Uttar Pradesh Public Services.** 5% horizontal reservation for ex-servicemen in the vacancies of Group 'C' and Group 'D' posts in Uttar Pradesh Public Service Commission along with 5% reservation in Group 'B' has been provided from Mar 2021.

**8. Regarding providing free bus travel facility to soldiers honoured with gallantry with gallantry award.** Gallantry award winners from Uttar Pradesh Transport Corporation are soldiers/officer of the armed forces who free travel facility is provided to citizens of the state in corporation buses. Commendation card given by a judge and the Air Force Chief is also valid for this facility.

**9. Special financial assistance to widows/families of martyred soldiers and disabled soldiers.** Uttar Pradesh government has approved special financial assistance at the rate of Rs. 15,000 and Rs. 10,000 per eligible person respectively to the widows /families of armed forces soldiers martyred in (Operation Pawan (Sri Lanka), Operation Meghdoot (Siachen) and to such disabled soldiers who have been retired due to disability.

**10. Grants to WWII Veterans / Wives of Deceased Servicemen.** The Uttar Pradesh Government gives grants to the ex-servicemen of World War II and their widows living in the state. From 21 Oct 2013, it was Rs.4, 000/-per month, which has been increased to Rs. 6,000/- per month wef 04 Feb 2016.

**11. Policy guidelines for starting the allotment of fair price shops in urban areas under the public distribution system to implement the current reservation system.** In Uttar Pradesh , 08% reservation has been provided in the allotment of fir price shops in urban areas to ex-servicemen and family members of solders killed in war and soldiers injured in war.

**12. Formation of District Sainik Bandhu.**

Under the letter No.1244/48-2008-96 (Mic)/91 TC-11 dt 20 Sep 2008 of Sainik Welfare Section, Government of Uttar Pradesh, an order was issued for formation of District Sainik Bandhu for prompt and appropriate action for redressal of problems of soldiers at distict level. Wherein the District Administration will give top priority and preference to redressal of problems of soldiers by maintaining consent vigilance in the direction.

13. **Training Program.** The following free training programs for the dependents of ex-servicemen are conducted by the Uttar Pradesh Government through recognized institutions:-

13.1. Information Technology Training	- 394 seats (480 hours training)
13.2. Computer Tally Training	- 60 seats (180 hours Training )
13.3. Computer Fashion Designing Training	- 110 seats (300 hours Training)
13.3. SSB Interview Training	- 75 seats (30 days Training)

#### **UTTAR PRADESH SAINIK REHABILITATION FUND.**

1. UP Sainik Punarvas Nidhi has been made schemes such as annual educational assistance, grant scheme for marriage of daughters of widows of ex-servicemen and waiver in loan taken by ex-servicemen for rehabilitation online, whose **websites** [www.upspnko.up.gov.in](http://www.upspnko.up.gov.in). Ex-servicemen/widows and their dependents can apply for financial grant through the said website.

##### **1.1. Annual Educational Assistance (per year).**

It has decided by the Honorable Mr Governor to increase the amount of financial assistance as follows from the financial year 2024-25:-

##### **1.2. Eligibility the following eligibility criteria are required to receive educational assistance.**

1.2.1. It is mandatory to apply online by 31 Oct as soon as the teaching/training session starts.

1.2.2. Students of class 9 and above are required to obtain 50% marks to pass the previous class. It is mandatory to have the mark sheet of the previous class verified.

1.2.3. Educational assistance is admissible only to two children of an ex-serviceman/widow.

1.2.4. Scholarship will be payable only to the children of ex-servicemen upto the rank of Hav. If the ex-servicemen is not alive then scholarship will be payable to the children of ex-servicemen upto the rank of JCOs.

1.2.5. Ex-servicemen should not be in any Government job.

1.2.6. Certificate to the effect that the applicant has not applied for financial assistance for the welfare purpose under any other scheme of the Government of India/State Government. The amount taken by the applicant knowingly has to be returned to the office.

2. **Financial assistance for marriage of daughters of widows of ex-servicemen.** It has been decided by the Honorable Shri Governor to increase the amount of Rs. 50,000/- previous given for the marriage of two daughters of widows of ex-servicemen (upto JCOS rank) from 01 Apr 2020 to Rs, 100,000/- per daughter.

#### **Qualifications.**

2.1. At the time of marriage the age of the daughter should be less than 18 years and the age of the groom should not be less than 21 years.

2.2. Certified copy of discharge book, certificate of complete date of birth of bride and from, marriage card or certificate of groom and boy, death certificate of ex-servicemen, certificate of solemnization of marriage, bank account details of widow of ex-servicemen (all forma verified) must be attached with the application.

2.3. There should be recommendation on the application (Form Format) of the Village Headman (Council Member head District Sainik Welfare Officer).

2.4. The application must reach the fund office within one year from the date of marriage, otherwise it will be considered time-barred.

2.5. If assistance has been received from the Government for this purpose, then the application should not be submitted to the Fund Office.

2.6. Certificate to the effect that the applicant has not applied for financial assistance for the said purpose under any other scheme of the Government of India/State Government. The amount taken internally by the applicant will have to be returned to the office.

3. **To wave off the loan taken by ex-servicemen for rehabilitation.**

3.1. The following discount is provided on the loan taken by ex-servicemen/their widow for their rehabilitation (Self-employment) from a nationalized bank, Co-operative bank, agricultural development bank or any other government financial institution (rates revised from 19 Jul 2019).

3.2. A rebate of 10% of the loan amount is payable on loans upto Rs. 5.00 lakh and 5% of the loan amount is payable on loan from Rs. 5,00,001/- to Rs. 10,00,000/-

3.3. In case where loan amount is more than Rs. 20,00 lakh, the loan amount shall be considered as Rs. 10.00 lakh only and rebate shall be given on the loan as per clause-(ii) of the said purposed scheme.

3.4. Ex-servicemen shall also be given exemption as above loan taken from the bank for technical education of his son/daughter (up to a maximum of tow children).

3.5. The application should be submitted to this office after six months from the date of receipt of loan.

3.6. The application should reach the fund office within 3 years from the date of first installment of loan repayment otherwise it will be considered time barred.

3.7. It is necessary to attach non-employment certificate, consumption certificate, copy of bank account, photocopy of discharge book, if vehicle has been purchased the photocopy of vehicle registration certificate (vehicle must be registered as taxi), photo copy of insurance, bank account details of ex-servicemen/widow alongwith application it is necessary to get all the form verified.

3.8. Discount is not allowed on cash credit loans. Discount will be allowed only on terms loans.

3.9. Certificate to the effect that the applicant has not applied for financial assistance for the same purpose under any other scheme of the Government of India/State Government. The amount taken by the applicant knowingly will have to be returned to the office.

4. Scheme to provided financial assistance to the dependents of ex-servicemen/their widows upto JCO rank of Uttar Pradesh who have passed NDA/IMA/OTA/AF Academy/Naval Academy/Women Entry. (Rates revised from March 2021). It has been decided to provide one time assistance of Rs. 25,000/- per son to upto two sons of ex-servicemen/their widows up to JCO rank (daughters will get the above amount alongwith additional financial assistance of Rs. 50,000/- per eligible person).

## **Qualifications**

4.1. To avail financial assistance, details are to be provided on the attached format. The following qualifications/documents are required:-

5.2. Certified copy of discharge book of ex-servicemen and his registration in the concerned District Sainik Welfare and Rehabilitation office alongwith the application.

5.3. Copy of certificate regarding selection in the above examinations.

5.4. Certificate from the Head of the Department regarding training in the above mentioned department/institution

5.5. Copy of the candidate's bank passbook indicating the name of the bank, account number, IFSC code.

5.6. Certificate copy of the death certificate in case of the ex-servicemen is not alive.

5.7. The application must reach the Fund Office within one year from the date of joining the training in the concerned Department/Institute otherwise it will be treated as time barred.

## **New Scheme**

5. In the 49<sup>th</sup> meeting of the management Committee of the Fund dated 13 Jan 2023, the Honorable Governor approved the operation of the following 04 Scheme from 012 Apr 2023:-

5.1. Medical Expenses Grant Re-imbursement of Medical expenses upto a max of Rs. 20,000/- in a financial year for treatment of dependents of ex-servicemen upto Hav rank (JCO rank in case of death) and their widow who are not eligible for ECHS Scheme.

6.1. Certificate from District Sainik Welfare and Rehabilitation office regarding the applicant not being a beneficiary of ECHS Scheme.

6.2. Certified copy of Discharge Book of ex-servicemen alongwith application.

- 6.3. Records related to disease/treatment in original(attested by the treating doctor).
- 6.4. Beneficiary's bank account details.
- 6.5. Certificate of annual income of the ex-servicemen from all sources provided by the Village Head/ Council Member.
- 6.6. Max limit of annual income is Rs. 3,00 lakh.
- 6.7. The application must reach the fund office within 01 year from the date of commencement of treatment otherwise will be considered time barred.
- 6.8. Certificate provided by the Village Pradhan/Council Member regarding not receiving any Government assistance for the same.
- 6.9. **Natural Disaster Grant.** Immediate effect lump sum financial assistance of upto Rs. 20,000/- to ex-servicemen upto the rank of Hav (JCO rank in case of non-survival)/there widows who have been affected by natural calamity.

## 7. Qualifications

- 7.1. Certificate from the Village Head/Council member regarding being effected by natural disaster.
- 7.2. Certified copy of Discharge Book of ex-servicemen alongwith application.
- 7.3. Beneficiary's bank account details.
- 7.4. Certificate of annual income of the ex-servicemen from all sources provided by the Village Headman/Council Member.
- 7.5. Max limit of annual income is Rs.3.00 lakh.
- 7.6. The application must reach the fund office within six months from the date of being affected by natural disaster, otherwise it will be considered as time barred.
- 7.7. Certificate provided by the Village Head/Council Member regarding not receiving financial assistance from any other sources for this purpose.

8. **One time financial assistance of Rs. 25,000/- to an orphan child of ex-servicemen up to JCO rank till pension facility is available (max 20 beneficiaries per year).**

## Qualifications

- 8.1. Certificate regarding the child being an orphan by the District Sainik welfare and Rehabilitation Officer.
- 8.2. Certified copy of the Discharge Book of the ex-servicemen alongwith the application.
- 8.3. Beneficiary's bank account details.
- 8.4. Certificate of annual income of the ex-servicemen from all sources provided by the Village Headman/Council Member.
- 8.5. Max limit of annual income is Rs. 3.00 lakh.

8.6. Birth date certificate of the beneficiary (up to 25 years for a child and till unmarried for a girl) boy and till unmarried for a girl).

8.7. Certificate regarding non-receipt of pension issued by the Sainik Welfare and Rehabilitation Officer.

9. Grant to disabled dependents of ex-servicemen upto Hav (JCO rank in case of death) and their widows and disabled wife of ex-servicemen, (Max 20 beneficiaries per year).

1. It has been decided to provide ex gratia financial assistance of Rs. 50,00,000/- (Rupees fifty lakh) to the families of the martyred soldiers of Central Paramilitary Forces/Armed Forces of other states/Paramilitary forces and Indian Army (including Army, Navy and Air Force) who are native residents of Uttar Pradesh and whose families are residing in Uttar Pradesh.
2. In the course of the above decision, for providing ex-gratia financial assistance to the dependents /families of the native residents of Uttar Pradesh whose families are residing in Uttar Pradesh and the Central Paramilitary Forces/Armed Forces of other states/Paramilitary Forces and the Indian Army (Army, Navy and Air Force) soldiers martyred during duty, the Governor specifies the following rules/sub rules/provisions and arrangements.

#### **Short Name , Start and expand.**

- 2.1. In relation to grant of ex-gratia financial assistance to dependents/families of martyred soldiers of Central Paramilitary Forces/Armed Forces of other states/Paramilitary Forces and Indian Army (Army, Navy and Air Force), the name of the executive order shall be known as.
- 2.2. This “executive Order” shall take effect on 01 Apr 2020.

#### **Definitions**

3. Martyrs are native residents of Uttar Pradesh, whose family is residing in Uttar Pradesh and who die in the line of duty while serving in Central Paramilitary Forces/Armed Forces of other states/Paramilitary Forces and Indian Army (Army, Navy and Air Force), due to terrorism, violence caused by activities of extremist anarchists, international war on the country's border or face-to face clash with the enemy, sporadic incidents or militant/terrorist/extremist activities, handling of explosives, medical reasons/extremes mountain heights/extreme border or natural calamities or extremes weather/accident etc. and are residents of outside Uttar Pradesh who are die in the line of duty under the same circumstances within Uttar Pradesh, will be considered as martyrs.

4. According to the said clause-2, the original residents of Uttar Pradesh whose family reside in Uttar Pradesh Ex-gratia financial assistance of Rs. 50,00,000/- (Rupees fifty Lakhs) to the dependents/ family of the Soldiers who are martyred in the line of duty while serving in Central Para Military Forces/ Armed Forces of other states/Paramilitary Forces and Indian Army (Army, Navy and Air Force) will be distributed in the following priority:-

- 4.1. If the martyr is married and one or both of his parents are alive, then for the family of the martyr, Rs. 35,00,000/- (Rupees thirty five lacs) will be distributed to his wife and Rs. 15,00,000/- (Rupees fifty lakhs) will be distributed to his parents or whoever of them is alive.

4.2. In the event of the martyr being married and neither of the parents being alive, a total Rs. 50,00,000/- will be distributed to the martyr's wife along with the amount admissible to the parents.

4.3. In the event of the martyr being unmarried, the family of the martyr along with the admissible amount a total of Rs. 50,00,000/- (Rupees fifty lacs) has be distributed to his parents or whoever is alive.

4.4. The above prescribed limits may be relaxed as per the need under special circumstances. However before giving any kind of relaxation or relaxing the above prescribed limits, it will be necessary to obtain a High Court order from the Home Department..

4.5. For granting exemption/relaxation in the prescribed limits as required under special circumstances, approval of Hon'ble Chief Minister would be essential.

4.6. For the purpose of giving ex-gratia financial assistance of Rs. 50,00,000/- (Rupees Fifty Lakh) to the dependents/family of the soldiers who are native of Uttar Pradesh and whose family is residing in Uttar Pradesh and who are members of Central Paramilitary Forces/Armed Forces of the states/Paramilitary Forces and Indian Army (Special Army, Indian Air Force ) who are martyred in the line of duty, it is mandatory to strictly follow the provisions mentioned in this order.

**ORDER**

The State government has taken a decision to take the dependents of soldiers/Paramilitary forces who are martyred in the line of duty while serving in the three services of the Armed Forces ( Army, Navy and Air Force) and Paramilitary forces, into government service.

The contents of the above decision, Sri Governor specifies the following rules/sub-rules/provisions and arrangements for employment of dependents of martyred soldiers/Paramilitary forces in government service.

1.1. This order shall be known as the 'Executive Order regarding compassionate appointment to the dependents of martyred soldiers who are domiciles of Uttar Pradesh'.

1.2. This order will be applicable for employment of dependents of martyred soldiers/paramilitary forces in Government service on or after the first day of April of the year 2017-18.

1.3. The dependents of the martyr will be employed in public service and other posts related to the functioning of the State Government of Uttar Pradesh but this will not apply to those service and post which come under the preview of the Uttar Pradesh Public Service Commission.

**Definitions** 2. Unless the context otherwise required, this Order shall include.

**2.1. Meaning of Battle Casualty soldiers**

Permanent/temporary appointment/commissioned officers/soldiers employed in connection with the operations of the three services and paramilitary forces who have been martyred in the line of duty during **Internal War, Shelling, Battle accidents, border clashes, terrorist/unlawful activities, natural calamities and vehicle accidents**.

2.2. A martyr missing while on duty at the time of the incidents mentioned in point (b) and who has been declared by a competent court.

2.3. The following shall be included in the seniority list under dependents of martyrs:-

**(In case the martyred soldier is married)**

1. Wife/Spouse (as the case may be)
2. Sons/widow daughters
3. Unmarried daughters
4. Legally adopted sons/adopted daughters

Father/mother

But in case of physical/mental unfitness of the above dependents, the dependents grandsons/unmarried granddaughters will be considered in the category of dependent.

**(In case the martyred soldier is unmarried)**

1. Father/Mother
2. Unmarried brother
3. Unmarried sisters
4. Married brother

(d) "Appointment Authority" means the Appointing as mentioned in the Rules for the post.

3. The application form for appointment of dependents of martyr will be addressed to Sainik Welfare Department, Uttar Pradesh for the three forces of Armed Forces and Home Department, Uttar Pradesh for Paramilitary Forces, in which, along with other required facts, date of death of the deceased martyr, Army/Paramilitary force unit and post (on which he was working before his death) will be clearly mentioned. Family details, educational and other qualifications of the applicant, and names of family members of the deceased martyr, their age, marriage, employment and income related details will also be mentioned in the application form.

4. The service related applications received from dependents of martyrs in the Department of Sainik Welfare, Uttar Pradesh and Home Department, Uttar Pradesh will be allotted to the concerned department for employment as per the roster system of the department.

5. For recruitment of a member of the dependents of a martyr, it will be necessary that the fulfills the educational qualifications prescribed for the post.

However, employees working in Government of India/State Government and Government institutions under them/retired employees and dependents of martyrs working on constitutional post/having worked in the past will not be considered eligible for service.

6. **If more than one member of the Martyr's family is eligible for employment, then in such a case, the first priority dependent submits a declaration that he is transferring his opportunity for employment to the next priority dependent. Only then the next priority dependent will be employed by the appointing authority. While employing, the welfare of the entire family, especially his parents and minor members, will be kept in mind.**

7. For appointment as dependent of martyr, the age of the candidate shall not be less than 18 years at the time of appointment. Applicants who have attained the age of superannuation will not be considered.

8. For the recruitment/appoint of dependents of martyrs, employment proceedings will be initiated by allocating the received applications through roster system of departments.

9. In the event of no vacancy existing in the Department concerned, such appointment shall be made against a supernumerary post which shall be deemed to have been created for the purpose and which will continue until a regular vacancy becomes available.

10. In relation to providing appointment/employment to the dependents of the martyrs and for determining department-wise roster, a high powered committee is constituted under the chairmanship of the Chief Secretary, Government of Uttar Pradesh as follows:-

**The final decision regarding the bio-logging of the martyred soldiers will be taken by the committee constituted as above.**

11. The Sainik Welfare Department, UP for the dependents of the deceased of the three services of the Armed Forces and the Paramilitary Forces will be nodal departments and will be responsible for organizing meeting under the Chairmanship of the Chief Secretary, Uttar Pradesh from time to time.

12. The High powered Committee constituted under the Chairmanship of the Chief Secretary, Uttar Pradesh Government may, for the purpose of removing any difficulty or defect in the implementation of this order, give such general or special orders as it may consider necessary or expedient for this purpose.

For the purpose of granting compassionate appointment to the dependents of martyred soldiers who are natives of Uttar Pradesh, strict compliance of the provisions mentioned in this order shall be binding on all the departments under the State Government.

In exercise of the powers conferred by clause (a) of sub-section(1) of section 9 of the Indian Stamp Act,1899 (Act No.2 of 1899), as amended in relation to its application to Uttar Pradesh, read with section 21 of the General Clauses Act,1897(Act No. 10 of 1897), the Governor, in supersession of Government Notification No 445/KA.NI/11-7-2013-500(64)-80 dt 17 May 2013, is hereby exempted from stamp duty chargeable under clause (a) of paragraph 23 of Schedule 1-B on instruments of transfer executed in favor of ex-servicemen and legal dependents of martyred ex-serviceman and legal dependents of martyrs of Para Military Forces and Central Armed Police Forces, and under paragraphs 35 of Schedule 1-B on instruments of lease, from the date of publication of this notification in the Gazette. 2. This exemption shall be admissible only once to the above mentioned person subject to eligibility.

Sir,

Please refer to your letter No.939/Stamp-Misc-25/2018 dt 14 May 2018. Regarding the above mentioned subject.

1. Notification No 25/2016/888/04-STD-2-2016-500(64)/80 dt 11 Nov 2016 was issued for providing exemption of stamp duty on transfer of properties up to the value of Rs. 20 Lakhs and lease deeds in favour of martyred soldiers legal heirs in favour of ex-servicemen. This notification provides for exemption from stamp duty chargeable under (a) of Articles 23 of Schedule 1-B on transfer deeds executed in favour of ex-servicemen and in favour of relatives of martyred soldiers and legal heirs of current servicemen of Burma and Central Armed under Articles 35 of Schedule 1-W on less instruments and his exemption will be available on the first valuation of the property up to Rs. 20 Lakhs and in case the valuation of the property is more than Rs. 20 Lakhs, stamp duty will be chargeable on the amount of valuation  
More than the first Rs. 20 Lakhs.

2. It has come to the notice of the Government that in the allotment of buildings and plots allotted by Housing Development and Development authority, husband and wife have been considered as one unit and if the registrant of the building is done in joint name, then on registration of buildings and plots, due to lack of clarity in respect of exemption of stamp duty on first valuation of property up to Rs. 20 Lakh under the aforesaid notification dated 11 Nov 2016, the allottees are getting the permissible exemption in common name only.

In the notification dated 11 Nov 2016 no mandatory condition is prescribed for transfer in the sole name of ex-servicemen or legal heirs of martyred soldiers in the respective deeds, that is this notification should be applicable in the situation where the legal heirs of ex-servicemen or martyred soldiers are joint transferees in any transfer or lease deed.

Due consideration in the matter it has been decided if in such documents the share of an ex-servicemen or a legal dependents of a martyred soldiers as transferee is up to Rs. 20 lakhs then he will be allowed the benefit of exemption to this extent.

## **ALLOCATION OF FAIR PRICE SHOPS IN URBAN AREAS UNDER PUBLIC DISTRIBUTION SYSTEM**

Policy guidelines for implementation of the current reservation system in the allotment of fair price shops in Urban areas under the public distribution system and for starting the allotment.

**Authority:** Uttar Pradesh government Order No 2714/29-6-2002-162 S/2001 dt 17 Aug 2002.

1. Following reservation system has been implemented by the Uttar Pradesh Government for the allocation/reservation of fair price shops:-

1.1.	Schedule Castes	-	21%
1.2.	Scheduled Tribes	-	02%
1.3.	OBC	-	27%

2. Following horizontal reservation shall be permissible within the above reserved categories:-

2.1.	Women belonging to the respective reserved categories	-	20%
2.2.	Family members of soldiers killed in action belonging to the respective reserved categories, ex-servicemen	-	08%
2.3.	Freedom fighter/his wife of the concerned reserved Category	-	05%
2.4.	Disabled persons belonging to the respective reservation Category	-	02%

3. Ensure horizontal reservation, shops will be marked through lottery system upto the prescribed percentage for family members of soldiers killed in battle/wounded soldiers or their family members, ex-servicemen, freedom fighters, their wives and handicapped persons. For "A", 'B', 'C', 'D' of Para 2, one slip each will be drawn sequentially till the marking of the prescribed reservation is completed.

It is noteworthy that candidates from any category can apply for unreserved vacancies. But the vacancies of reserved category will be filled from the same category.

### **SUBJECT : REGARDING EXEMPTION FROM HOUSE TAX TO EX-SERVICEMEN**

Sir,

Regarding the above mentioned matter, please refer to your letter No 5520/S.P-3 dated 18 Aug 2003. Through which a request has been made to exempt ex-servicemen from house tax.

In this regard, I have directed to say that the government has exempted from house tax only those residential buildings owned by widows of military personnel who have been martyred in the security of the country and in which they themselves are residing. This exemption is being given only under Municipal Corporation. It is not appropriate to provide exemption from house tax/water tax to ex-servicemen of the state keeping in view the financial condition of the state.

1. In relation to the above mentioned subject, please refer to Government Order No 1244/48-2008-96(Misc)/91.TC dated 20 Sep 2008, Government Order No 00CM/48-2015 dated 30 Mar 2015, through which detailed quid lines have been issued for formation of 'Zila Sainik Bandhu' and prompt action for redressal problems of soldiers through Lokwani Yojna.
2. The absence of prompt action by the district officers in the meetings of 'Zila Sainik Bandhu' regarding the difficulties faced by soldiers at their home in various cases, they are unable to solve many domestic problems such as property, land disputes and small problems created by anti-social elements during their short leave. The mental unrest caused by this affects the moral of the soldiers.
3. Zila Sainik Bandhu was formed/Lokwani Yojna was started to solve the problems of ex-servicemen/serving soldiers in a planned and timely manner but it seems that the Problems of the soldiers are not being taken seriously and meetings of Sainik Bandhu are not being held regularly due to which the problems of ex-servicemen and serving soldiers are not being solved on time. This situation is not appropriate in the national interest.
4. In connection with the above, I am once again directed to say that by ensuring strict compliance of the guidelines given in the above mentioned Government Orders, by holding regular meetings of Sainik Bandhu every month, take the trouble of resolving the complaints and problems received and ex-servicemen and their families in a timely manner.

**SCHEMES RUN FOR THE WELFARE OF EX-SERVICEMEN/WIDOWS AND DEPENDENTS OF UTTARAKHAND**

**Facilities provided by the state government of Uttarakhand**

1. **Gallantry Award.** The Uttarakhand government has made an unprecedented increase in the lump sum and annual grant given to the soldiers decorated with the gallantry medal of the state. The state of Uttarakhand has now become one of the states giving the highest amount in the country. The details of the amount given to the soldiers decorated with the gallantry medal award are as follows:

2. **Non Gallantry Medal Award.** The amount given to soldiers decorated with Non Gallantry Medal Award has been increased, which is as follows:-

3. **Travel in State Transport Buses.** Provision of free travel in state transport buses to Chakra Service Medal holders, ex-servicemen and servicemen widows.

4. **In pension of non-pensioner soldiers and military widows of World War II.** Former soldiers of World War and their widows who are not getting pension from any sources. Wef 07 September 2021, the pension amount has been increased from Rs. 8,000/- to Rs. 10,000/- per month.

5. **Uttarakhand Martyr Fund Grant.** A one time grant of Rs. 10,00,000/- is admissible to the widows/dependents of soldiers and paramilitary forces martyred in various wars, border clashes and internal security.

6. **Housing Assistance.** Housing assistance grant of Rs. 2,00,000/- is being given to the widows of war martyrs and servicemen retired on account of war disability.

7. **Exemption from house tax.** Government order has been issued to exempt ex-servicemen upto the rank of Hav and their widows from house tax who are residing in their own houses within the limit of various Municipal Corporation/Municipalities of Uttarakhand State.

8. **Stamp Duty Exemption.** Serving/ex-servicemen are allowed a 25% stamp duty exemption on transfer of immovable property up to Rs. 25,00,000/-

9. **Scholarship for Engineering and Medical Education.** Rs. 12,000/- for engineering, Rs.15,000/- for Medical education and Rs. 10,000/- for PhD education are being given every year from the Chief Minister Kargil Martyr Family Assistance Fund.

10. **Award for students under Higher Education Department.** Students of IIT, IMA, NIT, NDA and other professional and technical institutions established by the State Government who are permanent residents of the State are being given an award of Rs. 50,000/- each by the State Government.

11. **Special financial assistance to meritorious students under Higher Education Department's.** 50,000/- as special financial assistance for coaching etc to 1000 meritorious students of the state who have passed the preliminary examination of Group 'A' and 'B' conducted by Union Public Service Commission, State Public Service Commission and military institutions for preparation of main examinations/SSB etc, second examinations.

## **Employment**

13. **Appointment of one member of the family of martyred soldier in Group 'C' or 'D service under the State.** The Uttarakhand Government is providing appointment to one dependent of the family of martyred soldier through direct recruitment in Group 'C' or 'D' in the District Magistrate's Office.

14. **Reservation in Group 'C' in State Government services.** Ex-servicemen are allowed horizontal reservation of 5% in Group 'C' vacancies in State Government services.

15. **Employment of ex-servicemen/their dependents by Uttarakhand Ex-Servicemen Welfare Corporation Ltd (UPNL).** Ex-Servicemen/their dependents are employed in various institutions as per their qualifications by Uttarakhand Ex-Servicemen Welfare Corporation Ltd.

## **Training**

16. **Computer Training.** Training is being provided to ex-servicemen, servicemen widows and their dependents.

17. **Pre-recruitment Training.** In Dehradun District, 08 weeks of pre-recruitment training is being conducted five times a year for the sons of ex-servicemen of Garhwal and Kumaon divisions for recruitment in the Army/Police Forces. During this training arrangements for accommodation, uniform and food are free for the dependents of ex-servicemen.

**4. Incentive Grant to eligible candidates studying/teaching in Sainik School/Military School/RIMC.** One time incentive grant of Rs. 20,000/- will be provided to eligible Ex-Servicemen and Service Widows studying/teaching in Sainik School/Military School and RIMS to reimburse coaching expenses on admission to the educational institutions.

5. **Grant if reimbursement of coaching expenses on selection in NDA, IMA, OTA, Air Force Academy, Naval Academy, Civil Services, PCS, MBBS, IHM, IIT, IIM.** One time grant of Rs. 20,000/- or the amount spent, whichever is less, will be given to the dependents of ex-servicemen and servicemen widows for reimbursement of coaching expenses on selection/admission in NDA, IMA, OTA, Air Force Academy, Naval Academy, Civil Services, PCS, MBBS, IHM, IIT, IIM.

6. **Grant for training to war disabled ex-servicemen.** War disabled ex-servicemen of the state will be given grant for pursuing employment oriented and skill development courses from recognized training institutes up to the total expenditure or Rs. 20,000/- whichever is less.

7. **Incentive grant on selection of ex-servicemen dependents in sports.** In order to attract the children of ex-servicemen/servicemen widows of the state towards sports, the following incentive amount is admissible on selection at state, national and international level:-

7.1. At the state level	-	One Lakh
7.2. At the national level	-	Two Lakhs
7.3. At the internal level	-	Four Lakhs

8. **Grant on selection in Army, Para Military Forces, CPOs and State Police** After receiving training from pre-recruitment training conducted by Sainik Welfare Department, one time grant of Rs. 20,000/- is admissible on selection in Army, CPOs, Para Military Forces and State Police.

9. **Medical Expenses Re-imbursement.** After the Army started the "Ex Servicemen Contributory Health Scheme" for ex-servicemen, this scheme is applicable only to ex-servicemen/servicemen widows who are not entitled to pension, as follows:-

9.1. General Medicine	-	Rs. 10,000/-
9.2. Special treatment	-	Rs. Financial assistance will be given upto maximum 75% of the total expenditure or Rs. 1,00,000/- whichever is less.

10. **Subsidy on loan taken by ex-servicemen for rehabilitation.** The following subsidy is payable on loan taken by ex-servicemen/officer for his rehabilitation.

10.1. 10% subsidy will be payable on loan upto Rs. 5,00,000/- lakh.
10.2. 5% subsidy on loans above Rs. 5,00,000/- and upto Rs. 10,00,000/- lakh.

11. **Financial assistance for marriage of daughters of widows of ex-servicemen and orphan daughters of ex-servicemen.** One time grant of Rs. 1,00,000/- is admissible for marriage of daughters of widows of ex-servicemen/orphan daughters of ex-servicemen (upto two daughters).

12. **Grant for re-marriage of ex-servicemen widows.** On re-marriage of ex-servicemen widows, a lump sum amount of Rs. 1,00,000/- will be provided by the rehabilitation institution under financial assistance. This amount is provided in the form of FD for five years in the name of widow.

13. **Wheel Chair Assistance to Ex-Servicemen.** Wheel chairs are provided to disabled ex-servicemen on the basis of their application by the institution office through the District Sainik Welfare and Rehabilitation Officer.

14. **Assistance for serving/knitting machine to widows of ex-servicemen.** A grant of Rs. 3,000/- for purchasing sewing machine and Rs. 3,500/- for purchasing knitting machine is admissible to the widows of ex-servicemen for self-employment.

15. **Natural Calamity Grant.** Ex-Servicemen and servicemen widows are given financial assistance of Rs. 50,000/- for partial compensation in case of more than 50% damage to their private residential house in which they reside due to natural calamity such as earthquake, landslide, fire, flood, provided they have not received any financial assistance for the said calamity from any other sources.

16. **Scholarship for Pre-cum-Post Release Training.** Under this scheme, soldiers serving in the army are given training in ITI one year and six months before the date of retirement from the army, where the training fee is paid by DGR, Government of India, Ministry of Defence, New Delhi till the date of their retirement. If this training continues even after their retirement, then such ex-servicemen will be given Rs. 500/- per month as scholarship by the institute.

17. **Other assistance.** The Sainik Rehabilitation Institute, Uttarakhand provides the following grants every year to the training centres for maintenance of disabled ex-servicemen or their wives who are residents of the state and are undergoing training, health benefits or are residing in the rehabilitation institutes run under the patronage of the Government of India:-

17.1. Paraplegic Rehabilitation - Rs. 1,00,000/- per eligible Centre Mohali.

17.2. Paraplegic Rehabilitation - Rs. 1,00,000/- per eligible centre, Kirkee.

18. **Funds for District Sainik Welfare Council Meeting.** An amount of Rs. 5,000 per meeting is permissible for organizing meeting of District Sainik Welfare Council under the chairmanship of District Magistrates at district level to resolve problems of ex-servicemen and their dependents.

**Provide special medical grant to ESM dependents for serious/critical diseases.** After examining the standards, the proposal was approved in the meeting of special medical treatment to unemployed and unmarried dependent children of ESM and military pers/widows suffered from critical/very serious disease:-

1. **If treatment of disease listed under Atal Ayushman Yojna is done.** If the expdr exceeds Rs. 5 Lakh then the amt spent in excess of Rs. 5 Lakh or grant of Rs. 2 Lakh whichever is less.
2. Grant of amt spent on treatment of very serious illness which are not listed under Atal Ayushman Yojna or Rs. 2 Lakh whichever is less.
3. The decision of the executive committee has been implemented.
